Baseline Year & Current Reporting Year

Due to 2021 being the first year we have measured our CO₂e emissions, the report for the Baseline Year and Current Reporting year contains the same figures. Due to this, the explanations below apply to both sets of data:

Scope 1

Scope 1 is reported as 0 tCO₂e in the Baseline Year /Reporting Year due to Panamoure having no boilers, on-site manufacturing, a fleet or f-gases to report emissions on.

Scope 2

Within Scope 2, we have measured the emissions released from working from home and purchased gas. With all of Panamoure's employees making the most of hybrid working, we have calculated 2 out of 5 days as spent working from home and the other 3 from the office. Heating, lighting and computer consumption have all been taken into account to calculate emissions released due to working from home.

Scope 3

Business Travel

The Business Travel Subset in Scope 3 is reported as 3.8411CO₂e in 2021 due to Panamoure's business model. Travelling to customers' sites has also been calculated where public transport and petrol cars were used. We are looking to reduce these by having meetings over video conference using programs such as TEAMS.

Employee Commuting

Within Scope 3 we are currently tracking the modes of transport and types of vehicles Panamoure's employee are using to commute to work. Our employees are able to take advantage of our hybrid working which enable us to reduce our c0₂e.

Upstream transportation and distribution

We are tracking our upstream transportation and distribution in detail, Consequently, the subset, Upstream transportation and distribution is reported as 0.02tCO₂e and Downstream transportation and distribution 0.05tCO₂e for both our baseline year and our current reporting year.

Waste generated in operations

We are tracking our CO₂e released from our waste removal services using we are currently using for the building. Waste generated in operations 0.16 tCO₂e

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 28.97 tCO2e by 2040. This is a reduction of 5%
